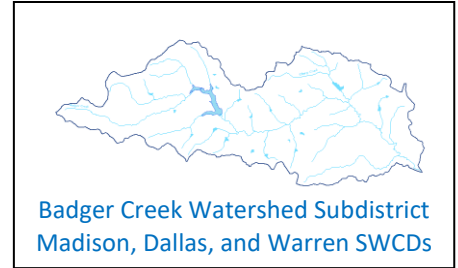

NOTICE TO PROSPECTIVE BIDDERS TREE & BRUSH REMOVAL

Project: Tree and brush removal on four Badger Creek Watershed structures located in Jefferson and Lee Townships in Madison County, Iowa

Work Involved (four dam structures):

- Herbicide spraying 10 days to 2 weeks prior to mowing or cutting
- Mowing and tree cutting as close to the ground as possible
- Treating stumps that are 2 inches or greater in diameter with herbicide
- Removing felled trees and piling below dams and out of flow areas

Expectations:

- Contractors shall maintain all applicable licenses and insurance* (see additional info on reverse)
- Work must be completed by July 31, 2026

Site Viewing:

- Friday, May 8, 2026 at 10:30 a.m.
- Meet on the road near 1318 Upland Lane, Van Meter (see map on reverse)

Submitting Bids:

Bids are due by 4:30 p.m. on Friday, May 15, 2026, and can be mailed or dropped off to the Madison County Soil & Water Conservation District (SWCD) office located at 815 IA-92, Winterset, IA 50273, or emailed to Anna.Golightly@ia.nacdnet.net

Bid packets should include the signed bidder cover sheet and the bid attached in the form of a quote.

Madison SWCD reserves the right to refuse any and/or all bids. All businesses that submit bids will be notified by phone after SWCD commissioners review the bids. The business that is awarded the project will also receive an official letter and a Services Agreement to sign and return with certificates of insurance.

The Contractor's insurance shall, among other things, be occurrence based and shall insure against any loss or damage resulting from or related to the Contractor's performance of this Contract regardless of the date the claim is filed or expiration of the policy. Madison Soil and Water Conservation District shall be named as an additional insured or loss payee, or the Contractor shall obtain an endorsement to the same effect, as applicable. All insurance policies required by this Contract shall remain in full force and effect during the entire term of this Contract and any extensions or renewals thereof and shall not be canceled or amended except with the advance written approval of the District. The Contractor shall submit certificates of insurance, which indicate coverage and notice provisions as required by this Contract, to the District upon execution of this Contract. The certificates shall be subject to approval by the District. The insurer shall state in the certificate that no cancellation of the insurance will be made without at least thirty (30) days prior written notice to the District. Approval of the insurance certificates by the District shall not relieve the Contractor of any obligation under this Contract.*
